# **Help Protect Farmworkers From Exposure to Pesticides**

Every year tens of thousands of farmworkers and their children are injured by exposure to pesticides. According to a US government study, the pesticide poisoning incidence rate among US



agricultural workers is 39 times higher than the incidence rate found in all other industries combined.

The Environmental Protection Agency's Worker Protection Standard, the law that establishes basic protections, hasn't been updated in more than 20 years. The result is thousands of preventable exposures, illnesses, and injuries for farmworkers and their families.

The proposed rules are open for public comment until August 18th. The time is now to stand up and demand stronger protections for farmworkers.
