The debate on fast track authority for new free trade agreements, including the Trans Pacific Partnership, is becoming very intense. A request for fast track authorization is expected to be introduced in congress within the next few weeks. If approved, it will open the door to trade agreements that could negatively impact family farms and local food systems in the U.S. and abroad.
